16/00643/FUL Erection of detached double garage Old Hall Farmhouse Main Street — Concerns were expressed about inaccuracies in the application, the proximity of the proposal to the neighbours property, the impact the proposal would have on the neighbouring property, the impact the development would have on surface drainage, concerns that there are a large number of vehicles currently parking at the property for which there will no longer be room, there is poor visibility on to the lane where the property is situated. The proposed development is considered to be out of keeping with other properties in the area

16/0728/FUL Replacement dwelling School Farm Back Lane – No objections to this proposal but would not like to see development creep in the area.
