Notes from meeting between Kerry Bailey, Derbyshire County Council, and Chris Ward, Hollington Parish Council, relating to the roll out of fibre broadband in Hollington. Meeting held at 6:30 PM on Friday 10th February.

#### **BROADBAND IN HOLLINGTON**

The purpose of this document is to share the information on Fibre broadband with our neighbours. Key points noted by myself during the meeting were as follows:

- BT OpenReach are laying FTTP (Fibre To The Premesis) at the north end of the village and FTTC (Fibre to the Cabinet, i.e. the last part of the connection is via copper wire) at the southern end due to the differing layouts and locations of phone cabinets in place.
- Scheme run as "Digital Derbyshire"; see details on last two pages, and http://www.digitalderbyshire.org.uk/ Jointly funded venture costing around £7M across 196 homes and businesses.
- Service providers for FTTP are currently limited to three (BT Retail, Andrews & Arnold and Zen were the cited during the meeting), though this may expand if enough people sign up. For FTTC the choice is much broader though no list was provided.
- DCC get quarterly updates on when an exchange or home will get the service but only in arrears, meaning they cannot tell us when the remaining parts of the village will be connected.
- NOT EVERY HOME WILL GET A FIBRE CONNECTION. For those that do not there are alternative means of support in the form of Wireless or satellite based services via the Better Broadband Subsidy Scheme (see below).
- Small businesses can get support from two schemes, which can be used in combination to get training and help with hardware to obtain faster broadband.

# **Notes from Kerry Bailey: Derbyshire County Council**

The Digital Derbyshire programme is providing fibre-optic broadband to communities by primarily upgrading existing BT cabinets in areas that currently cannot receive fibre services via a commercial supplier. The Digital Derbyshire targets (as part of a national framework set by central government) are for every Derbyshire premise to be able to receive a download speed of 2Mbps and for ninety-five percent of premises to receive download speeds of 24Mbps by the end of 2018.

In certain areas of Derbyshire a fibre to the premise (FTTP) solution is being utilised, which is where the fibre optic cable runs all the way to the premise. We are pleased to advise that the Digital Derbyshire programme has upgraded the infrastructure in the majority of Hollington (particularly via Brailsford cabinet 1, which is FTTP). This means that many residents can now order fibre broadband up to 330Mbps from an internet service provider (ISP) of their choice. Please be aware that not all ISPs offer FTTP services, this is the choice of the service provider (see the first attachment).

A small proportion of Hollington falls within the second phase of our programme, as they are fed from either Great Cubley cabinets 1 and 3. Due to the complex nature of the work involved with the cabinets, we are unable to advise on expected uplift in speed for individual homes, or give a more specific timeframe of completion in advance. We receive confirmation from Openreach once the cabinets have gone live and been through BT's internal checks, tests and assurances. At this point we will be able to communicate out to residents that the work has been completed via the parish council.

# **Better Broadband Subsidy Scheme**

Central government has committed to giving access to a broadband service with at least a 2Mbps download speed to every premises in the UK. As part of this commitment, BDUK has initiated a voucher scheme (Better Broadband Subsidy Scheme), which can be redeemed (up to £350) with independent suppliers of wireless, satellite or 3/4G for eligible premises. http://www.digitalderbyshire.org.uk/better\_broadband\_subsidy\_scheme/default.asp Under the Better Broadband Subsidy Scheme, Derbyshire businesses and residents can claim up to £300 (wireless) and £350 (satellite) towards hardware, installation, commissioning and activation. The on-going monthly costs are excluded from the scheme, but residents should be able to find a package that suits their requirements.

It is a relatively quick process, residents need to answer no to the question about BT providing less than 2Mbps (if this is the case), and confirm that they have not received more than €200,000 in EU funding (if applying as a business) in the last 3 years.

Once they have received a code, they will then be able to obtain quotes from approved suppliers (the Derbyshire ones include W3Z, Big Blue Rocket, Derbyshire Broadband, NotSpot and Pine Media). The full list of approved suppliers can be reviewed via the following link –
